BUSINESS OPERATIONS:

Through daily shoreside cargo handling operations and overnight sailings, we move approximately 8 million tons of cargo or 200,000 twenty-foot container/platform equivalents (CPE), per year through our Honolulu hub facility to and from the Neighbor Islands.

RATES*:

Young Brothers' affordable freight rates are regulated by the Public Utilities Commission and allow customers to ship items from Honolulu to the Big Island at these rates:

- \$61 for a 40 cubic foot pallet of canned goods
- \$81 for a 60 cubic foot pallet of beverages
- \$301 for a mid-sized car to ship one-way, and an additional \$124 for round-trip within 30 days
- \$694 for a 20-foot Young Brothers container of general cargo

WHO WE ARE:

Young Brothers has been an integral part of the Hawai'i community for over 115 years. ORIGIN:

Brothers Herb, William, and Jack Young established Young Brothers in 1900. Thirteen years later the firm was incorporated as Young Brothers, Limited, and expanded to provide ocean towing, rescue service and barge transportation between the islands. Young Brothers got its start in the interisland market by providing ocean transportation services between O'ahu and Moloka'i.

OWNERSHIP:

In 1999, Saltchuk Resources, Inc., a Seattle-based company, acquired Young Brothers. Saltchuk is a privately owned family investment company formed in 1982. Saltchuk includes a large family of diversified transportation and distribution companies that support each other in fulfilling their respective missions. Saltchuk companies serve the continental U.S., Alaska, Hawai'i, and Puerto Rico, and conduct international operations on behalf of U.S. customers.
