WATER CARRIER INFLATIONARY COST INDEX (WICI) ADJUSTMENT EXEMPTION (OPTIONAL)

Customers eligible for preferential agricultural water rates under HRS §269-26.5 are exempt from the WICI adjustment and must provide reasonable documentation demonstrating eligibility (e.g., a recent water utility bill reflecting receipt of preferential agricultural water service rates). Such documentation must be submitted by the customer and validated by YB prior to the application of the exemption. Validation can take up to two (2) weeks following receipt of complete and accurate documentation. The exemption cannot be applied retroactively under any circumstances. Validated customer documentation of eligibility will remain effective until July 1st of the following year. To maintain eligibility, customers must resubmit supporting documentation annually, beginning after May 1st of each year.
